

Interpretations & Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of these Terms and Conditions:

- Application means the software program provided by the Company downloaded by You on any electronic device, named LobbyFox
- Application Store means the digital distribution service operated and developed by Apple Inc. (Apple App Store) or Google Inc. (Google Play Store) in which the Application has been downloaded.
- Affiliate means an entity that controls, is controlled by or is under common control with a party, where "control" means
 ownership of 50% or more of the shares, equity interest or other securities entitled to vote for election of directors or other
 managing authority.
- Country refers to: Kentucky, United States
- Company (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to ETA Media LLC, 2425 Nashville Rd., B3, Bowling Green, KY 42101.



Definitions (cont)

For the purposes of these Terms and Conditions:

- Content refers to content such as text, images, or other information that can be posted, uploaded, linked to or otherwise made available by You, regardless of the form of that content.
- Device means any device that can access the Service such as a computer, a cellphone or a digital tablet.
- Feedback means feedback, innovations or suggestions sent by You regarding the attributes, performance or features of our Service.
- Free Trial refers to a limited period of time that may be free when purchasing a Subscription.
- In-app Purchase refers to the purchase of a product, item, service or Subscription made through the Application and subject to these Terms and Conditions and/or the Application Store's own terms and conditions.
- Service refers to the Application.
- Subscriptions refer to the services or access to the Service offered on a subscription basis by the Company to You.
- Terms and Conditions (also referred as "Terms") mean these Terms and Conditions that form the entire agreement between You and the Company regarding the use of the Service.
- Third-party Social Media Service means any services or content (including data, information, products or services) provided by a third-party that may be displayed, included or made available by the Service.
- You means the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.



Acknowledgment

These are the Terms and Conditions governing the use of this Service and the agreement that operates between You and the Company. These Terms and Conditions set out the rights and obligations of all users regarding the use of the Service.

Your access to and use of the Service is conditioned on Your acceptance of and compliance with these Terms and Conditions. These Terms and Conditions apply to all visitors, users and others who access or use the Service.

Subscriptions Period

The Service or some parts of the Service are available only with a paid Subscription. You will be billed in advance on a recurring and periodic basis (such as daily, weekly, monthly or annually), depending on the type of Subscription plan you select when purchasing the Subscription.

At the end of each period, Your Subscription will automatically renew under the exact same conditions unless You cancel it or the Company cancels it.

Subscriptions Cancellations

You may cancel Your Subscription renewal either through Your Account settings page or by contacting the Company. You will not receive a refund for the fees You already paid for Your current Subscription period and You will be able to access the Service until the end of Your current Subscription period.

If the Subscription has been made through an In-app Purchase, You can cancel the renewal of Your Subscription with the Application Store.



Billing

You shall provide the Company with accurate and complete billing information including full name, address, state, zip code, telephone number, and a valid payment method information.

Should automatic billing fail to occur for any reason, the Company will issue an electronic invoice indicating that you must proceed manually, within a certain deadline date, with the full payment corresponding to the billing period as indicated on the invoice.

If the Subscription has been made through an In-app Purchase, all billing is handled by the Application Store and is governed by the Application Store's own terms and conditions.

Fee Changes

The Company, in its sole discretion and at any time, may modify the Subscription fees. Any Subscription fee change will become effective at the end of the then-current Subscription period.

The Company will provide You with reasonable prior notice of any change in Subscription fees to give You an opportunity to terminate Your Subscription before such change becomes effective.

Your continued use of the Service after the Subscription fee change comes into effect constitutes Your agreement to pay the modified Subscription fee amount.



Refunds

Except when required by law, paid Subscription fees are non-refundable. You may cancel Your free trial, anytime up until the day of expiration, by notifying us in writing of Your cancellation request. Notifications may be sent to Your assigned LobbyFox representative or accounting@lobbyfox.com. At that time, You will be provided with shipping labels to return any and all equipment to LobbyFox. Should those devices not be returned by You within 30 days or arrive damaged because of Your misuse, negligence or neglect, LobbyFox reserves the right to charge You for the damage with the billing information You provided. Damage that occurs in transit by the carrier does not apply. At any time and without notice, the Company reserves the right to (i) modify the terms and conditions of the Free Trial offer, or (ii) cancel such Free Trial offer.



Lifetime Warranty

With an active and paid subscription, LobbyFox warrants to the original end user customer of its hardware that its hardware is free from defects in material and workmanship. LobbyFox warrants to the original end user of its hardware that hardware that is damaged during use will be replaced. LobbyFox will, at its option, either repair or replace any part of its hardware that proves defective by reason of improper workmanship or materials. Repaired parts or replacement hardware will be provided by LobbyFox on an exchange basis, and will be either new or refurbished to be functionally equivalent to new. If LobbyFox is unable to repair or replace the hardware, it will refund the current value of the hardware at the time the warranty claim is made.

This limited lifetime warranty does not cover any damage to any hardware that results from improper installation, abuse, misuse, natural disaster, abnormal mechanical or environmental conditions, repair, or modification. This limited lifetime warranty does not apply to improper installations of hardware that result in peeling or bubbling of hardware. This limited lifetime warranty does not apply to any hardware on which the original identification information has been altered, obliterated or removed, has not been handled or packaged correctly, has been sold as second-hand or has been resold contrary to applicable law. This limited lifetime warranty covers only repair, replacement or refund for defective hardware or for hardware that are damaged during use. LobbyFox is not liable for, and does not cover under warranty, any costs associated with removing or installing LobbyFox's hardware. Lifetime warranty is valid only on active subscriptions. If the end user cancels the LobbyFox subscription, the warranty is null and void. SMS Opt In:

LobbyFox is a visitor management software system (VMS) that sends text messages for notifications and confirmations. Businesses purchase this software to electronically record visitors arrival and departure.

Visitors: Visitor is defined as any person not employed by that business.

When visitors arrive at a business using a LobbyFox VMS and present a phone number to the kiosk upon check-in, that phone number may receive automatically generated text messages. The content of those text messages is defined by the business the visitor is checking in to. The purpose of those text messages sent by the LobbyFox kiosk can include: confirming/acknowledging check-in, providing links to documents completed during check-in, relevant meeting/visit/delivery information, emergency notifications or any other content the business may elect to send you. LobbyFox does not share visitor information with anyone except the business where the visitor used our product. LobbyFox will never use, share or sell visitor information. To opt-out of text messaging from the LobbyFox visitor management system, contact the kiosk administrator at the business you visited or send an email to optout@lobbyfox.com. Please include your name, phone number and the business that you checked-in to/received the text from.

Host/Employee: Host is defined by any employee of the business that a visitor can check-in to meet. Employee is defined as a person employed by the business but does not receive visitors through the kiosk. The business that employs the host/employee provided the phone numbers to text to the LobbyFox VMS. When visitors arrive at a business using a LobbyFox VMS and check in to see a host, the host and/or other employees may receive automatically generated text messages. The content of those text messages is defined by the business that employs the host. The purpose of those text messages sent by the LobbyFox kiosk can include: notifying/acknowledging check-in, providing links or images, relevant meeting/visit/delivery information, emergency notifications or any other content the hosts' employer may elect to send. Hosts/employees can receive text messages unrelated to visitors. The content and purpose of those text messages is defined by the business that employs the host/employee. LobbyFox does not share host or employee information with anyone except the business where they are employed. LobbyFox will never use, share or sell visitor/host/employee information. To opt-out of text messaging from the LobbyFox visitor management system, contact the kiosk administrator or HR department at your place of employment.



Content

Your Right to Post Content

Our Service allows You to post Content. You are responsible for the Content that You post to the Service, including its legality, reliability, and appropriateness.
